Chapter 1 Welcome to Nanning

I. City Overview

Nanning, backed by the vast southwest region of China and facing the Beibu Gulf, is the capital of the Guangxi Zhuang Autonomous Region, a multi-ethnic province. It serves as the political, economic, cultural, educational, scientific, and financial hub of the entire region and stands as a gateway and forefront for China's open cooperation with ASEAN. Known by the laudatory titles of China's Green City and A Land Where Folk Songs Thrive, Nanning has been honored with several prestigious awards, including the United Nations Habitat Scroll of Honor, National Civilized City, National Ecological Garden City, National Sanitary City, National Forest City, and China's Outstanding Tourism City.

1. Administrative Divisions

Nanning, covering a total area of 22,100 square kilometers, governs 7 districts: Xingning, Jiangnan, Qingxiu, Xixiangtang, Yongning, Liangqing, and Wuming, as well as 5 counties (county-level cities): Hengzhou, Binyang, Shanglin, Mashan, and Longan. Additionally, it is home to three national-level development zones: the Nanning High-tech Industrial Development Zone, the Nanning Economic and Technological Development Zone, and the Guangxi-ASEAN Economic and Technological Development Zone.

2. Population and Ethnic Groups

Nanning, the capital city, is a melting pot of various ethnic groups, including the Zhuang, Han, Yao, Miao, Dong, and others. As of the end of 2022, the city's permanent population stood at 8.89 million.

3. Ecologically Livable

Over the past five years, Nanning has consistently maintained an excellent air quality rate of over 94%, with ambient air quality meeting standards for six consecutive years. The term "Nanning Blue" has become synonymous with the city's environmental quality. In 2021, the city achieved a 100% rate for the quality of surface water in its main waterways. Nanning has been recognized as one of the first National Ecological Garden Cities and as an outstanding pilot city for sponge city construction. It is the only city in China to have been honored as a Beautiful Mountain and Water City for three consecutive years. In 2021, Nanning reached several milestones: the service radius coverage of parks and green spaces within the urban area was 80.18%, the green space coverage was 36.2% within its built-up area, and the average green space per person was 12.13 square meters in the urbanized area.

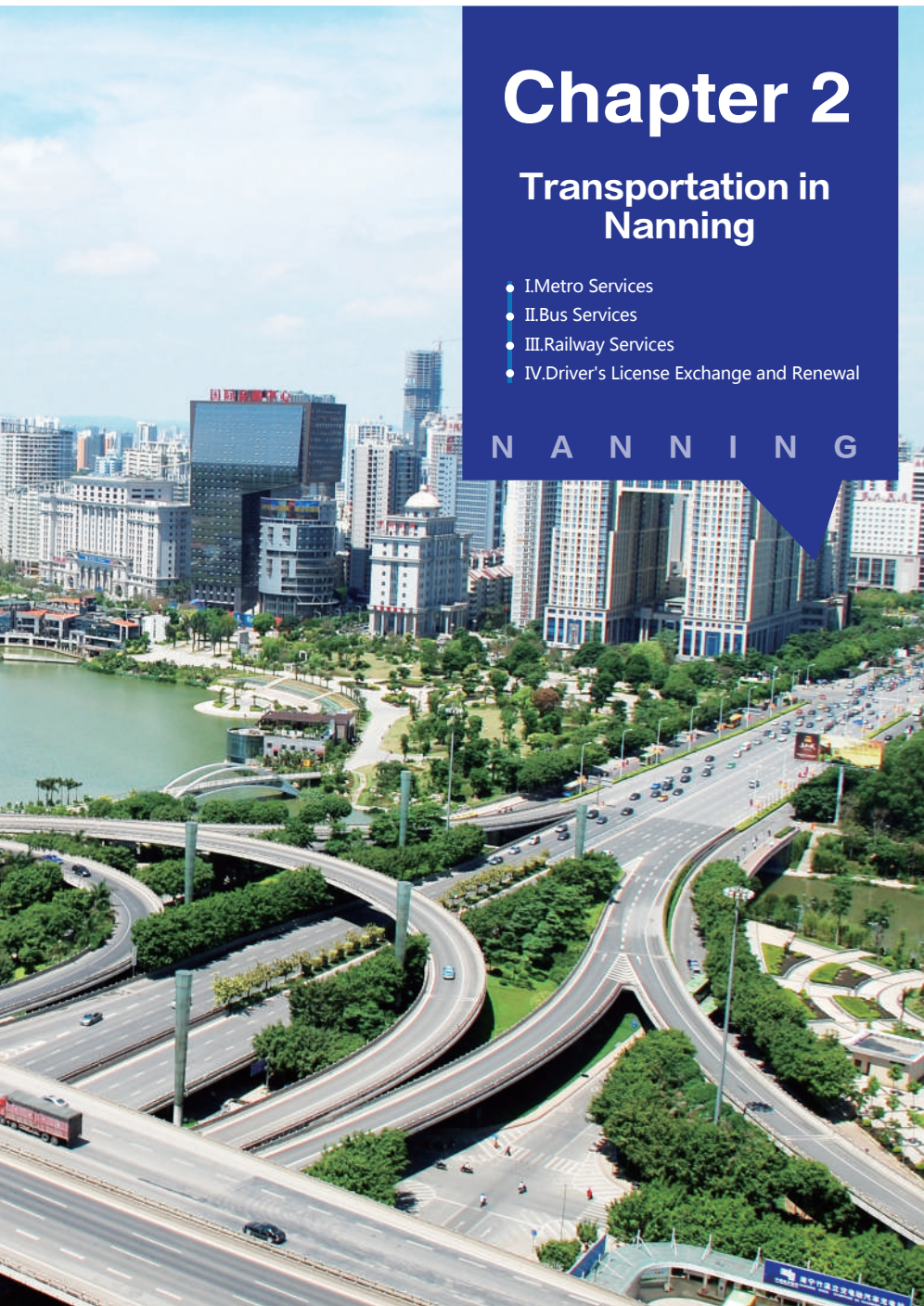

Chapter 3 Living in Nanning

I. Residence Guidelines for Foreigners in Nanning

1. Residence and Stay

(1) Foreigners holding a visa with a stay duration not exceeding 180 days must stay within China in accordance with the duration specified on their visa.

If a foreign national needs to extend their stay, they must apply to the Exit-Entry Administration Department of the Public Security Bureau under the local People's Government at or above the county level at least seven days before the expiration date indicated on their visa. They must submit the required supporting documents.

Upon review, if the reasons for the extension are deemed reasonable and sufficient, the stay duration may be extended. If the extension is not granted, the foreign national must leave China by the specified date. The total extension period must not exceed the original stay duration specified on the visa.

(2) For a foreigner whose visa indicates that a residence permit is required upon entry into China, they must apply for a foreigner's residence permit at the Exit-Entry Administration Department of the Public Security Bureau under the local People's Government at or above the county level within thirty days of their entry.

A foreigner applying for a residence permit must submit their passport or other international travel documents, along with materials

relevant to the purpose of their application, and provide biometric identification information such as fingerprints. The Exit and Entry Administration Department of the local Public Security Bureau shall review the application materials within 15 days of receipt and issue a residence permit of the appropriate category and duration based on the purpose of residence.

The validity period of a work-related residence permit ranges from a minimum of 90 days to a maximum of five years. For non-work-related residence permits, the validity period ranges from a minimum of 180 days to a maximum of five years.

(3) Foreign nationals who are at least 16 years old and residing or staying within China must carry their passport or other international travel documents, or their foreign residence/stay permits at all times, and must allow public security organs to inspect these documents.

A foreigner residing in China must, within the specified timeframe, present their residence permit to the public security organ of the local People's Government at or above the county level in their place of residence.

(4) The registration items for a foreigner's residence permit include: the holder's name, gender, date of birth, reason for residence, duration of stay, date of issuance, place of issuance, and the number of their passport or other international travel documents.

Should there be any changes to the registered items on a foreigner's residence permit, the holder must apply to the Exit-Entry Administration Department of the local People's Government at or above the county level within ten days of the change to process the alteration.

(5) Foreign nationals residing or staying within the territory of China must not engage in activities that do not correspond with the

purpose of their stay or residence.

(6) For foreign infants born within the territory of China, their parents or agents shall, within 60 days after the birth of the infant, hold the birth certificate of the infant and go to the Exit-Entry Administration Department of the local People's Government at or above the county level where the parents reside to handle the stay or residence registration for the infant.

(7) In the event of the death of a foreign national within the territory of China, their family members, guardians, or agents shall, in accordance with regulations, submit the foreigner's death certificate to the Exit-Entry Administration Department of the Public Security Bureau under the local People's Government at or above the county level to declare and cancel the foreigner's residence or stay permit.

(8) Foreign nationals are prohibited from forging, altering, obtaining by fraud, or using visas and certificates under false pretenses.

(9) Without approval, foreigners are not permitted to enter areas restricted to foreigners.

(10) Foreign nationals working in China must obtain a work permit and a residence permit for work in accordance with relevant regulations. No entity or individual may employ a foreign national who has not obtained the aforementioned permits.

2. Accommodation Registration

(1) Foreign nationals staying at hotels within the territory of China must have their accommodation registered by the hotel in accordance with the relevant regulations on public security management for the hotel industry, and the hotel shall submit the foreign guests' registration information to the local public security organs.

(2) Foreign nationals residing or staying at a place other than a hotel must register with the local public security organs within twenty-four hours of check-in, either personally or through the person providing the accommodation.

(3) Foreign nationals who reside in Nanning for an extended period and temporarily stay elsewhere must also complete the accommodation registration process.

3. Law and Order

(1) No one shall disturb public order, engage in group fights, provoke brawls, or insult women.

(2) No one shall endanger public safety by illegally carrying or storing firearms, ammunition, or controlled knives.

(3) No one shall infringe upon others' personal rights, assault others, illegally restrict others' personal freedom, or illegally intrude into others' residences.

(4) The consumption of opium, the injection of morphine, and other drug-related activities are strictly prohibited. Additionally, the trafficking and transportation of drugs are also strictly prohibited.

(5) Prostitution, solicitation, and providing conditions for prostitution are strictly forbidden.

(6) Producing, duplicating, selling, renting, or disseminating obscene books, paintings, videos, or any other obscene materials are strictly prohibited.

(7) Foreign nationals must apply to and obtain permission from Nanning Municipal Public Security Bureau to hold assemblies, parades, or demonstrations. Foreign nationals are not allowed to participate in assemblies, parades, or demonstrations organized by Chinese citizens

without approval from the public security organs.

4. Religious Activities Management

(1) Foreign nationals may participate in religious activities at legally registered places of worship. Collective religious activities for foreigners should be conducted in temples, monasteries, or churches that are legally registered and recognized by the religious affairs department, or at temporary locations designated for collective religious activities by the provincial religious affairs department.

Foreign nationals visiting in the capacity of religious clergy, upon invitation from provincial religious organizations, may preach or conduct religious teachings at legally registered places of worship. Foreign religious clergy who enter China under other identities, upon invitation from provincial religious organizations and with the consent of the provincial religious affairs department, may preach or conduct religious teachings at legally registered temples, monasteries, or churches.

(2) Foreign nationals engaging in religious activities within religious venues in China must comply with Chinese laws and regulations, respect the religious beliefs and customs of the personnel at these venues, adhere to the rules and regulations of the religious venues, and submit to the management of these venues.

(3) Foreign nationals are prohibited from establishing religious organizations, setting up religious offices, creating venues for religious activities, or founding religious educational institutions and training classes under any name or form within China. They are also prohibited from developing followers, appointing religious clergy, or engaging in any other illegal missionary activities among Chinese citizens. Additionally, they are not allowed to recruit students for the purpose of

training religious clergy for study abroad without authorization, nor are they permitted to distribute religious propaganda materials.

5. Miscellaneous Matters

(1) Foreign nationals holding a foreign driver's license must not drive a motor vehicle in China unless they have passed the assessment conducted by the public security traffic management department and have been issued a Chinese driver's license.

Foreign nationals holding a Chinese driver's license must not violate relevant laws and regulations, including the Road Traffic Safety Law of the People's Republic of China.

(2) Foreign nationals who lose or have their passports stolen must immediately report the loss or theft to the local Public Security Bureau. With the police report issued by the public security organs, they should then register the loss at the Exit-Entry Administration Division of the Nanning Public Security Bureau. After an investigation and verification, the Exit-Entry Administration Branch of the Nanning Public Security Bureau will issue a Certificate of Lost Passport. The passport owner must then obtain a new passport from their country's embassy or consulate in China and subsequently handle visa and other related procedures at the Exit-Entry Administration Branch of the Public Security Bureau.

(3) Foreign nationals who lose or have their property stolen must immediately report the incident to the local Public Security Bureau. With the police report provided by the Public Security Bureau, they should then register the loss at the Entry-Exit Administration Branch of the Nanning Public Security Bureau. After an investigation and verification, the Branch will issue a Certificate of Lost Property.

IV. Housing Provident Fund

State organs, state-owned enterprises, urban collective enterprises, foreign-invested enterprises, urban private enterprises, and other urban enterprises, institutions, private non-enterprise units, and social organizations (hereinafter collectively referred to as "units") are required to make contributions to the housing provident fund for their employees. According to the "Nanning Housing Provident Fund Contribution Management Measures," foreign nationals who have established a labor relationship with employers in Nanning and hold a "Foreigner's Permanent Residence Identity Card" may contribute to the housing provident fund in accordance with regulations, based on mutual agreement with their employers.

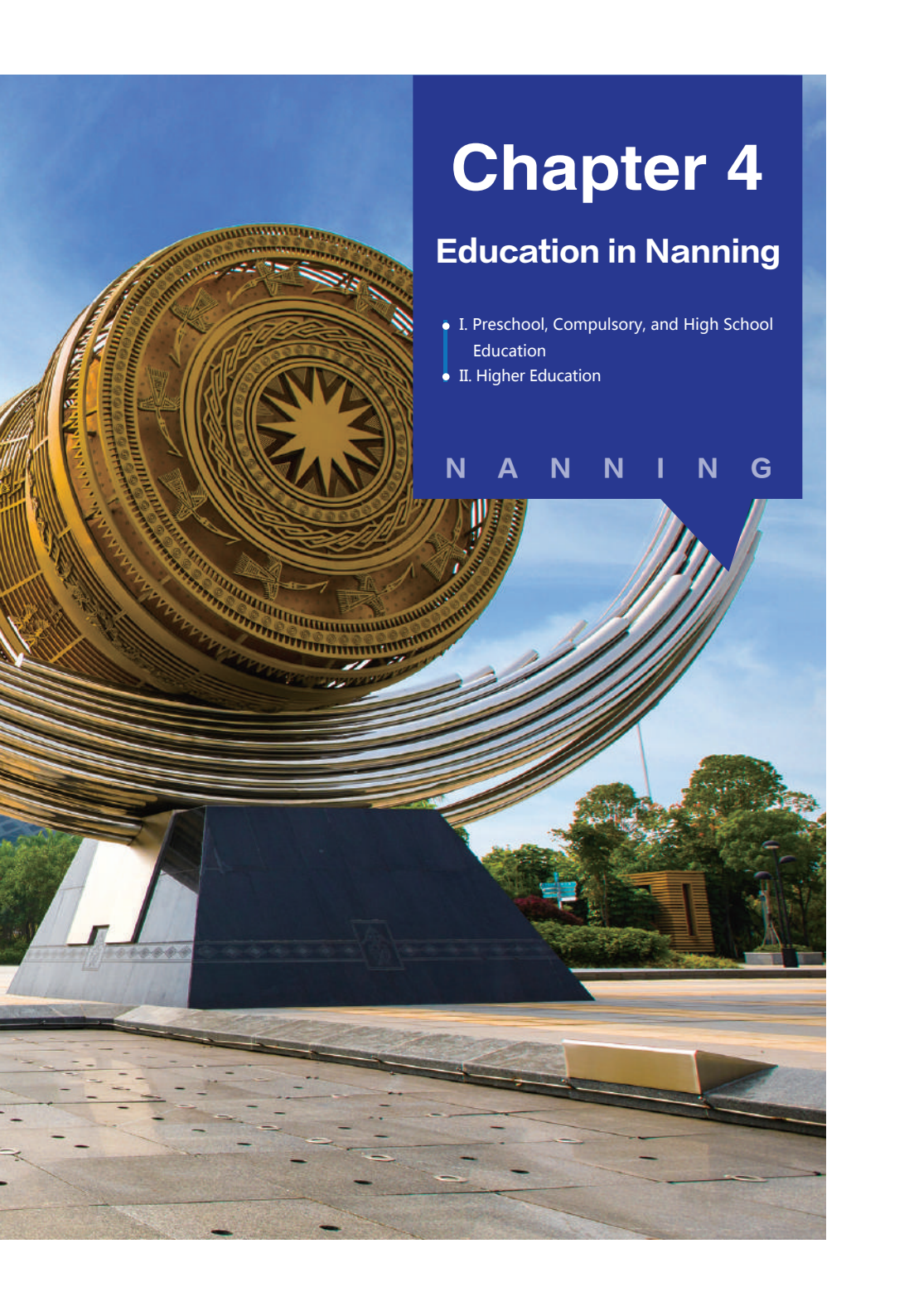

Chapter 4 Education in Nanning

Foreign children of school age in Nanning are eligible to apply for schools that have the qualification to enroll international students. They can directly submit their applications to the schools they wish to attend, and if the school reviews and approves the application, admission will be granted.

3. Education for Children of High-Level Talents Identified by Nanning

(1) For the children or grandchildren of high-level talents recognized by Nanning, who wish to enroll or transfer to public or private inclusive kindergartens, or compulsory education stage schools within the city, their admission or transfer will be coordinated based on the family's actual residence and educational resource availability. Talents categorized as A, B, and C will be handled by the municipal education administrative department, while those at levels D and E will be addressed by the respective county (city, district), and development zone education administrative departments. Those participating in the city's high school entrance examination will receive the same treatment as local residents during the admission process.

(2) For overseas talents introduced to Nanning, the Nanning Municipal Education Bureau or the education administrative departments of their respective counties (cities, districts), and development zones will provide services including policy consultation on compulsory education enrollment and arranging for nearby school placements for their children.

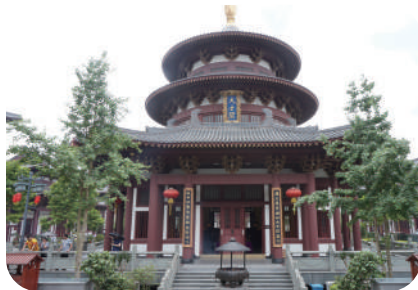

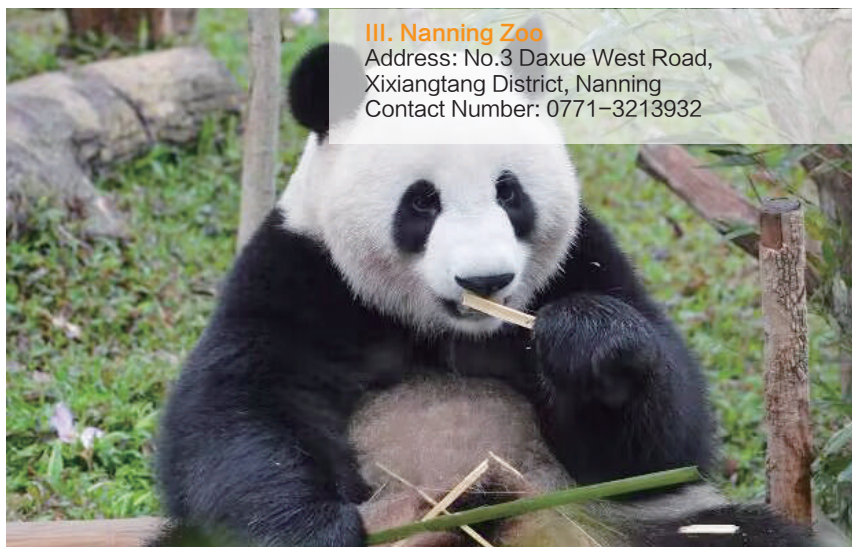


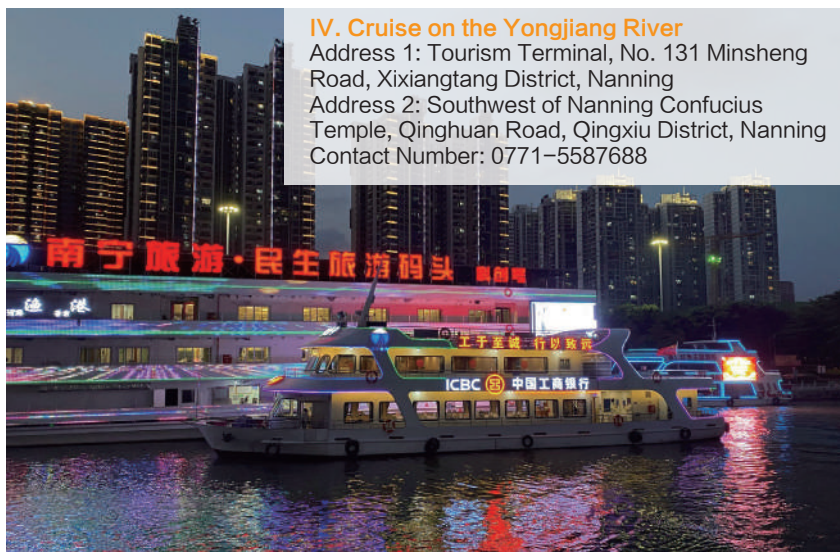

III. Authentication/Certification Services

The Convention on Abolishing the Requirement of Legalization for Foreign Public Documents (hereinafter referred to as the "Convention") came into effect in China on November 7, 2023. Traditionally, the consular certification process for foreign documents required both "notarization" and "authentication" procedures. With the Convention in effect, the requirement for diplomatic or consular authentication of foreign public documents has been abolished. An Apostille issued by the foreign affairs authorities is all that is needed for a document to be used in all contracting states, eliminating the need for the 'authentication'

process. This greatly facilitates the certification and transmission of the legal effectiveness of international documents for the applicants.
